2021 WAS A UNIQUE YEAR FOR EDUCARE WITH COVID-19. THE NON-PROFIT WAS ABLE TO EXPAND SERVICES INTO MARSHALL, HICKMAN, LEWIS AND PERRY COUNTIES, PROVIDING DIRECT ASSISTANCE TO 60-75 PEOPLE PER MONTH. THE DUI COURT HAD 35 ACTIVE PARTICIPANTS AND THE MENTAL HEALTH COURT HAD 15 PARTICIPANTS PER MONTH. FINALLY DUE TO COVID-19 AND AN INCREASE IN FEDERAL FUNDING, THE NON-PROFIT HAS BEEN ABLE TO EXPAND ITS SUBSTANCE ABUSE SERVICES INTO MORE RURAL AREAS. THEY EXPECT FOR SERVICES IN THIS AREA TO CONTINUE TO GROW THROUGHTOUT THE NEXT FISCAL YEAR.
