EXCLUSIVELY PROVIDE SERVICES TO THOSE AFFECTED BY SEXUAL VIOLENCE.
DIRECT SERVICES TO SURVIVORS INCLUDE THERAPY, ADVOCACY, 24/7 HOTLINE,
AND A 24/7 SAFE CLINIC THAT PROVIDES MEDICAL, LEGAL, RAPE EXAMS TO
VICTIMS OF SEXUAL ASSAULT 16 YEARS OR OLDER, THROUGH A PARTNERSHIP WITH
NASHVILLE GENERAL HOSPITAL AND LAW ENFORCEMENT. LAST YEAR SAC SERVED
OVER 1,000 VICTIMS/SURVIVORS. SAC PROVIDED OVER 12,000 THERAPY AND
ADVOCACY SESSIONS AND RESPONDED TO OVER 2,200 HOTLINE CALLS. 93% OF
