WE PROVIDE HUMAN TRAFFICKING SURVIVORS LONG TERM, COMPREHENSIVE, SPECIALIZED, TRAUMA-INFORMED AFTERCARE THROUGH BOTH IN- HOUSE SERVICES AND OTHER COMMUNITY SERVICE PROVIDERS. WE HAVE A SAFE HOUSE WITH 8 BEDS WHERE SURVIVORS CAN LIVE RENT FREE FOR SIX MONTHS WHILE THEY PARTICIPATE IN OUR PROGRAM.
