JMI'S TRANSITIONAL LIVING HOME/PROGRAM IS DESIGNED TO PROTECT YOUNG WOMEN WHO ARE AT RISK OF HUMAN TRAFFICKING. THEY ARE PROVIDED WITH A HOME, FOOD, LIFE SKILLS EDUCATION, BUSINESS SKILLS, EDUCATION, MENTORING AND COMPUTER SKILLS EDUCATION. JMI'S TRANSITIONAL LIVING HOME FOR BOYS PROVIDES SIMILAR SERVICES TO YOUNG MEN WHO ARE AT HIGH RISK FOR SUICIDE AND BEING TARGETED BY ORGANIZED CRIME GROUPS IN MOLDOVA.

WE ALSO OFFER EMERGENCY RELIEF IN THE FORM OF FOOD BAGS DURING THE FLOODING SEASON IN THE AMAZON. JMI ALSO HAS A SPONSORSHIP PROGRAM THAT HELPS FUND BIBLE TRAINING FOR JUNGLE PASTORS AND ANOTHER TO HELP FUND THE BUILDING AND MAINTENANCE OF SCHOOLS IN REMOTE AMAZON VILLAGES.
