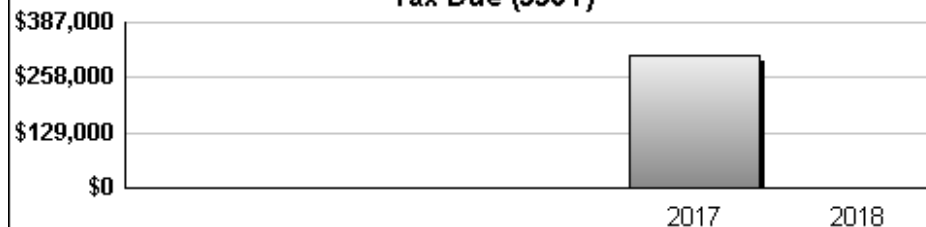


Business Income (990T)
