THE THREE-MEMBER ARBITRATION COMMITTEE WILL DETERMINE BY MAJORITY VOTE THE ISSUE. THE COMMITTEE SHALL FOLLOW THE PROCEDURAL RULES OF THE AMERICAN ARBITRATION ASSOCIATION. THE DECISION OF THE COMMITTEE WILL BE BINDING ON TENNGREEN AND THE DONORS.

WHEN TENNGREEN DETERMINES THAT AN EASEMENT GRANTOR IS IN VIOLATION OF THE TERMS AND CONDITIONS OF THE EASEMENT, TENNGREEN WILL GIVE WRITTEN NOTICE OF THE VIOLATION(S) TO THE GRANTOR AND REQUEST CORRECTIVE ACTION. IF THE
