Adoptions of animals to the public - We start by accepting an animal and giving it proper medical attention and preparing it for adoption. Each animal, regardless of age, is spayed or neutered prior to going home, given its appropriate vaccinations and treated for any and all illnesses that can be treated. In 2021 we rescued 712 animals into the adoption program (363 Canine, 349 Feline).

Transportation of Animals directly from animal shelters and from situations in counties who have no animal shelters. These animals are transported to partner shelters in the north who have a lack of variety of animals in their shelters and have room to accept animals from our community. In 2021, we rescued and transported 703 (467 Canine, 236 Feline) animals from our local animal shelters and counties without shelters to our rescue partners.
