The grant paid for 15 Safepoles used by patients with IVs in the myelosuppression unit. These innovative poles enable patients to be more mobile while they are in the hospital. They are much safer and have covered domes that eliminate tripping and prevent tubes from getting tangled in the wheels. The grant was possible, in a large part, by the Walters family.

We also provided patient luncheons and gift bags with such items as gas cards and convenience items. In addition, scholarships were given to students at Adamsville High School, as selected by their scholarship
