INTERPRETING SERVICES SERVED 732 INDIVIDUALS, NOT INCLUDING STUDENTS AND AUDIENCES. ALMOST 24,000 HOURS OF INTERPRETING SERVICES WERE PROVIDED BY TWO STAFF INTERPRETERS AND MORE THAN FORTY CONTRACT INTERPRETERS, INCLUDING 423 HOURS BY DEAF INTERPRETERS. CERTIFIED DEAF INTERPRETERS (CDIS) ARE HIGHLY-QUALIFIED INTERPRETERS WHO TEAM WITH HEARING INTERPRETERS TO MEET THE SPECIFIC NEEDS OF CLIENTS WHERE THERE IS AN ADDITIONAL LANGUAGE BARRIER.

INTERPRETING SERVICES ALSO PROVIDED 2,611 VIDEO REMOTE INTERPRETING (VRI) MINUTES. VRI ALLOWS US TO PROVIDE SERVICES QUICKLY AND COST-EFFECTIVELY TO REMOTE AREAS BUT NEVER REPLACES THE VALUE AND QUALITY OF HAVING AN INTERPRETER IN PERSON.

YOUTH EDUCATION & SERVICES, DUBBED THE 'THE SIGNING ACES,' (ADVOCACY, COMMUNITY, EMPOWERMENT) HAD A GREAT YEAR.

BABY ACE & ME SERVES DEAF CHILDREN AND FAMILIES FROM BIRTH TO 2.5, PROVIDING WEEKLY CLASSES IN FOUR, EIGHT-WEEK SESSIONS THROUGHOUT THE YEAR. JR. ACE & ME SERVES CHILDREN FAMILIES FROM 2.5 TO SCHOOL AGE.

THESE EARLY INTERVENTION PROGRAMS ADDRESS THE SEVERE LANGUAGE DEPRIVATION DEAF CHILDREN BORN TO HEARING PARENTS. ALMOST 95% OF DEAF CHILDREN ARE BORN TO HEARING PARENTS, 75% OF WHOM NEVER LEARN TO SIGN. CHILDREN IN OUR EARLY INTERVENTION PROGRAM SHOWED A NINE TO TEN-POINT INCREASE ON THE LANGUAGE DEVELOPMENT SCALE IN BOTH EXPRESSIVE AND RECEPTIVE LANGUAGE.

TWENTY-EIGHT STUDENTS FROM MIDDLE TENNESSEE WERE ENROLLED IN THE
