ROCK THE WALL STREET, WALL STREET (RTWS) IS A "HANDS ON" FINANCIAL PROJECT EDUCATION PROGRAM WHOSE MISSION IS TO ENGAGE, EXCITE AND ENLIGHTEN HIGH SCHOOL GIRLS ABOUT FINANCIAL MATH SO THEY BEGIN MANAGING THEIR OWN MONEY AT AN EARLY AGE. RTWS TAKES A THREE-PRONGED EDUCATIONAL APPROACH THROUGH CLASSROOM WORKSHOPS, WALL STREET EXPERIENCE FIELD TRIPS, AND MENTORSHIP/PROTEGE PROGRAMS. THE PROGRAM BEGAN IN NASHVILLE IN 2013 AND EXPANDED INTO OTHER CITIES INCLUDING MEMPHIS, NEW YORK CITY, CHICAGO, DALLAS/FT. WORTH, CHARLOTTE, AND MOST RECENTLY IN LOS ANGELES. SINCE 2013, RTWS HAS SERVED NEARLY 1000 HIGH SCHOOL FEMALES, BUILT 30+ SCHOOL AND COMMUNITY PARTNERSHIPS, AND HAD MORE THAN 400 FINANCIAL VOLUNTEERS DEDICATE THEIR TIME AND TALENT TO THE PROGRAM.
