#### INDEPENDENT AUDITOR'S REPORT

To the Board of Directors of Senior Citizens of Hendersonville, Inc.

We have audited the accompanying financial statements of Senior Citizens of Hendersonville, Inc. (a nonprofit organization), which comprise the statement of financial position as of June 30, 2015, and the related statements of activities, functional expense and cash flows for the year then ended, and the related notes to the financial statements.

## Management's Responsibility for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America; this includes the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

### Auditor's Responsibility

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. # NOTE 1 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Nature of Activities

Senior Citizens of Hendersonville, Inc. (the "Center"), was incorporated under the laws of the State of Tennessee on July 31, 1986, for the purpose of operating a senior center in Hendersonville, Tennessee to service Hendersonville and Sumner County citizens sixty years of age or older. The Center provides on-site programs in addition to an outreach program to homebound seniors. The Center utilizes a fiscal year beginning July 1 and ending on June 30.

Basis of Accounting

The financial statements have been prepared using the accrual basis of accounting in accordance with generally accepted accounting principles in the United States of America.

Income Taxes

The Center is a non-profit organization that is exempt from income taxes under section 501(C)(3) of the Internal Revenue Code.

The Center's Forms 990, Return of Organization Exempt from Income Tax, for the fiscal years 2015, 2014 and 2013 are subject to examination by the IRS, generally for the three years after they are filed.

Cash & Cash Equivalents

Cash and cash equivalents include all monies in banks and highly liquid investments with maturity dates of less than three months. The carrying value of cash and cash equivalents approximate fair value because of the short maturities of those financial instruments.

Use of Estimates

The preparation of the financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from these estimates.

Basis of Presentation

Net assets and revenues, expenses, gains and losses are classified based on the existence or absence of donor-imposed stipulations. Accordingly, net assets of the Center and changes therein are classified and reported as follows:

<u>Unrestricted net assets</u> – Net assets that are not subject to donor-imposed stipulations.

# NOTE 1 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Temporarily restricted net assets – Net assets subject to donor-imposed stipulations that may or will be met, either by actions of the Center and/or the passage of time. Restrictions that are fulfilled in the same accounting period in which the funds are received are reported in the statement of activities as unrestricted. The Center has no temporarily restricted net assets at June 30, 2015.

<u>Permanently restricted net assets</u> – Net assets subject to donor-imposed stipulations that they be maintained permanently by the Center. The Center has no permanently restricted net assets at June 30, 2015.

All contributions are considered to be available for unrestricted use unless specifically restricted by the donor. Contributions of cash or other assets that must be used to acquire property and equipment are reported as increases in temporarily restricted net assets until the assets are acquired and placed in service as instructed by the donor. Amounts received that are designated for future periods or restricted by the donor for specific purpose are reported as temporarily restricted or permanently restricted support that increases those net asset classes.

## Contributed Services

Contributed services are reflected in the financial statements at the fair value of the services received only when those services either (a) create or enhance nonfinancial assets, or (b) require specialized skills that are provided by individuals possessing those skills and would typically need to be purchased if not provided by donation. Services that do not meet either of the preceding criteria should not be recognized. The Center received several hundred hours of volunteer services during the fiscal year which do not meet stated criteria and therefore are not recorded.

### Program Expenses

Program services include events, activities or transactions in which the Center provides to service Hendersonville and Sumner County citizens sixty years of age or older.

## Advertising Costs

Advertising costs are expensed as incurred.

## NOTE 2 – GRANT INCOME

The Center is the recipient of an unrestricted grant administered by Greater Nashville Regional Council on behalf of the United States Department of Health and Human Services and the Tennessee Commission on Aging in the amount of \$31,225. The grant is comprised of federal Title III-B Award of \$18,550, a Title III-D Award of \$75, and the Tennessee Commission on Aging Award of \$12,600. Grant receivable consists of \$7,275 due from Greater Nashville Regional Council for 2014-2015 fiscal year.

## **NOTE 3 – CONTRIBUTIONS**

Senior Citizens of Hendersonville, Inc. received \$14,372 in unrestricted contributions from corporations and individuals during the fiscal year ending June 30, 2015. The Center also received unrestricted contributions of \$11,500 from the United Way, \$12,000 from Sumner County, Tennessee and \$13,000 from the City of Hendersonville, Tennessee.

## NOTE 4 - CASH

The Center's cash balance at June 30, 2015 consists of \$63,068 cash in bank.

# NOTE 5 - PROPERTY AND EQUIPMENT

Property and equipment are recorded at cost or, if donated, at the estimated fair market value at the date of donation. The policy of the Center is to capitalize all assets \$250 and above. Property and equipment are depreciated using the straight-line method over the life of the asset, between three and fifteen years. Leasehold improvements are depreciated over the assumed life of the lease, see Note 8. Donated property and equipment is stated at an estimable fair market value on the date received.

Depreciation expense for the year ending June 30, 2015 totaled \$10,424. Repair and maintenance costs are expensed as incurred.

## NOTE 8 – GIFTS IN KIND

The Center was the recipient of rent in-kind from the City of Hendersonville during the fiscal year ending June 30, 2015. The City values the cost of the contribution for the use of the building at 197 Imperial Boulevard to be \$30,000. Accordingly, in-kind revenue and rent expense of \$30,000 was recorded by the Center. The lease agreement is openended and cancelable by the City at any time, however not for the foreseeable future.

Other gifts-in-kind during the fiscal year were immaterial.

# **NOTE 9 – OPERATING LEASES**

The Center maintains an operating lease for a copier with Digitec. The lease was renewed on March 4, 2015 and is valid for 12 months. The monthly minimum fee is \$45 for 3,000 copies.

# NOTE 10- SUBSEQUENT EVENTS

The Center has evaluated events and transactions for subsequent events that would impact the financial statements for the year ended June 30, 2015 through November 30, 2015, the date the financial statements were available to be issued. There were no subsequent events that require recognition in the financial statements.
