The non-profit was able to expand services into Marshall, Hickman, Lewis and Perry counties, providing direct assistance to 60-75 people per month. The DUI court had 35 active participants and the Mental Health court had 15 participants per month. Finally due to Covid-19 and an increase in federal funding,the non-profit has been able to expand its substance abuse services into more rural areas. They expect for services in this area to continue to grow throughout the next fiscal year.
