Disability Services: The Supportive Living Program is designed to provide quality in-home support for individuals with developmental disabilities. They receive health care coordination, transportation and around the clock assistance and support.

4b (Code: ) (Expenses \$ 3,817,471. including grants of \$ ) (Revenue \$ 36,496. )

Homeless Services: Programs include eviction prevention program, family emergency shelter, healing beds, transitional housing, family follow up program, and permanent supportive housing. These programs reach out to homeless families, women with disabilities and their children, and pregnant and parenting teens by providing housing and intensive case management.

Substance Abuse: The organization offers a complete system of care ranging from community outreach, prevention, assessment, outpatient treatment, long term residential treatment and aftercare services. The programs are designed to provide clinical services by licensed and trained addiction treatment professionals with a focus on recovery. Specialized services are offered to women and children, families, veterans, individuals with HIV/AIDS, those transitioning from correctional institutes, and persons with mental issues.
