


Activities in fiscal year 2015 were a result of a Tennessee Constitutional Amendment referendum that gave state lawmakers more power to restrict and regulate abortions. Known as Amendment 1, this referendum was seen by the Taxpayer as significant threat to its purpose and existence and the Taxpayer needed to take "self-defense" action. This activity in 2015 is significantly higher than any other activity by the Taxpayer in its entire existence and is not expected to occur again. The Taxpayer would have had safeguards to prevent excess lobbying expenditures, but its staff misunderstood the rules and requirements. The Taxpayer have now hired tax counsel and safeguards have been put in place too prevent this unintentional situation from happening again. Given Amendment 1 was such an attack on Taxpayer's purpose, the Taxpayer felt obligated to defend itself and those it seeks to help and serve.

This letter is being sent to explain the excess lobbying expenditures of the above taxpayer (the "Taxpayer"). The Taxpayer admits that it had excess lobbying expenditures in its last fiscal year, and most of these expenditures came from grassroots lobbying. In late 2014, Tennessee held several Constitutional Amendments. The one most applicable to the Taxpayer was known as Amendment 1 which gave state lawmakers more power to restrict and regulate abortions in Tennessee. Prior to Amendment 1, the Tennessee Supreme Court in Planned Parenthood of Middle Tennessee v. Sundquist, 38 S.W.2d 1(Tenn. 2000), had broadly authorized abortions in Tennessee and ruled that the state legislature had little authority to regulate abortions under the Tennessee Constitution. Amendment 1 was the response to this ruling.

With the Taxpayer's mission to provide access to reproductive, sexual and complementary healthcare services and information; provide educational programs that enhance understanding of human sexuality; and advocate for public policies that guarantee these rights and ensure access to these services, Amendment 1 was a direct attack on the Taxpayer and its mission. The Taxpayer saw Amendment 1 as a way to restrict access to necessary healthcare services and information and felt obligated to advocate, in self-defense, against Amendment 1. This was the biggest attack on the Taxpayer in many years and it was hardly fought by both sides, with more than \$5 million being spent for and against this measure. For comparison, approximately \$4 million was spent in Tennessee's contemporaneous gubernatorial election.

Given the amount of money spent by both sides and the infrequent nature of Amendment 1, the Taxpayer should not be punished by having its non-profit status revoked. Of course, the tax on the excess lobbying expenditures is being paid and the Taxpayer is not arguing against the imposition of the tax. The Taxpayer is only asking that its tax exempt status not be revoked.

The Taxpayer's staff misread the rules and requirements regarding lobbying expenditures. Had they understood them, the amount of excess would be drastically reduced or non-existent. However, that is not the case. The taxpayer and its staff have been advised by me on what the rules and restrictions are and have put in place safeguards to prevent future excess expenditures. Given this misunderstanding by the staff and the intermittent nature of Amendment 1, the Taxpayer asks for forgiveness and to be able to keep its tax-exempt status in place.

The Taxpayer acted reasonably given the circumstances and exercised ordinary business care and prudence and respectfully requests that the IRS not revoke its tax-exempt status. Please feel free to call me at (615) 238-6315 to discuss this matter further. Thank you for your time.
